- C Interference due to co-elution.

- H Non-homogenous samle matrix affecting RPD and/or QC.I Manual Integration was performed.
- L Duplicate sample relative precent difference (RPD) exceeds QC limits.
- M Anomalous results due to matrix interference
- P Peaks manually split.
- Q1 QC out of limits but still oK
- Q2 Quality Control outside QC limits. Data considered estimate.
- Q3 CCV was above the acceptance criteria. Non-detect samples are considered acceptable.
